BOARDING AGREEMENT

THIS AGREEMENT enter into this _____ day of _____ 20_____ between WOUNDED BEAR FARMS AND KENNELS, hereinafter referred to as WOUNDED BEAR, and _____ hereinafter referred to as OWNER.

WOUNDED BEAR agrees to board the OWNER'S animal(s) for a daily fee of \$_____.

OWNDER agrees that WOUNDED BEAR shall not be liable for damages of any kind or nature accruing from any cause whatsoever, including but not limited to, loss by fire, theft, running away, loss, or injury to the animal(s).

OWNER agrees that they shall be solely responsible for any and all injuries and/or damages occurring to themselves or any other parties and by any and all acts of the animals and agrees to indemnify and hold WOUNDED BEAR harmless thereof.

OWNER agrees that if a veterinarian is needed in the care of injury or sickness, WOUNDED BEAR may call owner's vet at the OWNER'S expense. Or if the OWNER'S vet is not available WOUNDED BEAR may call any other vet to assist and treat.

All animal(s) boarding at WOUNDED BEAR must be healthy and vaccinated on a regular basis, and a statement to that effect must be submitted to the office for the OWNER'S file.

Daily boarding fees must be paid when animal(s) is picked up, or monthly if animal(s) is kept on a long term basis. WOUNDED BEAR has the right to place a lien on OWNER'S animal(s) and equipment in lieu of payment. If this right is exercised OWNER will be notified in writing and will have ten days to make payment, or relinquish animal(s), registration papers, and equipment to WOUNDED BEAR. In obvious cases of abandonment OWNER will be notified as described above and, if not claimed, animal(s) will be disposed of as per Authority: AS 08. 98. 050.
